Procedure:





1. For receiving the suggestions/complaints a box shall be kept in the library all days during the working hours of the college.

In the meeting it was decided to repair the blade board and the switch boards.









The meeting of the Students Grievance Cell was 2021-22

The meeting decided to replace the glasses, to help the students to attend the classes comfortably.

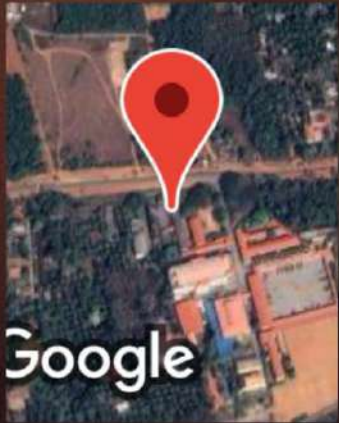




