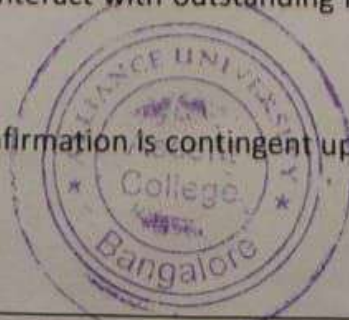



### Does my deposit count as advance payment towards my fees?

Yes, we will confirm in your CAS statement that you have paid £3500 in advance towards your total tuition fees due.

### When do I have to pay?

### Can I pay more than £3500 towards my tuition fees?

### Do I get a refund if I don't register?




